## TERMS AND CONDITIONS OF SALE

**Terms:** Terms for Paragon Luxury Wheels are Net 10<sup>th</sup> Prox, with the 25<sup>th</sup> of the month the last purchase day of the purchasing period and the 26<sup>th</sup> being the first day of the new purchase period. Accounts will be considered past due if payment is not received by the 10<sup>th</sup> of the month.

**Service Charges:** All accounts which are past due shall incur a monthly service charge of 1.5% (18% APR) of the past due balance. Service charges will be assessed on the day the portion of the account balance becomes past due and each month thereafter for which the balance remains past due.

**Returned Checks:** All returned checks are subject to service charge of at least \$40.

**Accounts Placed For Collection:** To the extent allowed by law, the Applicant agrees to pay all costs of collection incurred by Paragon Luxury Wheels relating to this application or the applicant's account including reasonable attorneys' fees and costs, without regard to whether a lawsuit or arbitration has commenced. Any legal action arising out of the extension of credit by Paragon Luxury Wheels to Applicant shall be governed by the laws of the State of North Carolina, without regard to conflict of law rules. Applicant irrevocably submits to the jurisdiction of the federal and state courts located in North Carolina and waives any objection it may have to either the jurisdiction or venue of such forum.

The undersigned hereby grants Paragon Luxury Wheels a security interest in all products and goods purchased by Applicant from Paragon Luxury Wheels and hereby authorizes Paragon Luxury Wheels to file such Uniform Commercial Code filings as necessary to protect such security interest.

The undersigned unconditionally personally guarantees the payment and performance obligations of the Applicant that occur under this agreement with Paragon Luxury Wheels.

**Change of Ownership:** Paragon Luxury Wheels requires written notification stating change of ownership is required 30 days prior to the ownership change. Failure to provide said notification will obligate applicant for any post ownership obligation to Paragon Luxury Wheels.

**Returns:** It is the policy of Paragon Luxury Wheels that the freight costs for any product returns accepted by Paragon Luxury Wheels will be the responsibility of the Applicant. No cash refunds will be given. If the applicant' account is delinquent with Paragon Luxury Wheels, it is at the sole discretion of Paragon Luxury Wheels to accept return merchandise to be credited to said delinquency. Absolutely no wheels will be accepted for return if the said product has been mounted or damaged in any way.
